

PRIVACY POLICY

This Privacy Policy is launched by SANBUN INVESTMENTS

SANBUN INVESTMENTS understands the value of maintaining your privacy. We respect and value your privacy and respect your trust in us. This Policy explains how we handle the user information we gather on <https://www.sanbuninvestments.biz> and other offline sources. This Privacy Policy pertains to existing visitors to our website and to our online customers. Your visit to our website suggests that you agree with our privacy policy.

Information we usually ask for: Contact Information, including your name, email, mobile number, phone number, street, city, state, pin code, country and IP address.

Payment and Billing information: We collect your billing name, billing address, and payment method when you make any transaction with us. We never ask for your credit card number, credit card expiry date, or other details pertaining to your credit card on our website. Credit card information is obtained and processed through our online payment partner.

Information you post: We gather information you post in public space, on our website, or on a third-party social media forum belonging to SANBUN INVESTMENTS.

Other Information: If you use our website, we obtain information regarding your IP address and the browser you use. We may have a look at what site you originally came from, duration of time that you spend on our website, pages accessed or what site you will subsequently visit when you leave us. We may also collect information regarding the mobile device you are using while visiting our website, or the version of the operating system your computer or device is running on.

We collect information through different mediums: Information directly from you: Information directly from you when you make registration for any event or buy any program. We may also gather information through your comment on our websites or phone or email.

We gather information from you indirectly: Through tracking tools, such as Google Analytics, Google Webmaster, browser cookies.

Personal Information: We use this information to contact you when you we have any update. We may use the information that we get to contact you for confirmation of any order that you place on our website or for other promotional purposes.

Requests or questions: We might use your information to confirm your registration for an event or contest.

Security purposes: Information is used to protect our customers, our website, and our company.

Marketing Purposes: We send you information regarding special promotions or offers. We also tell you about new features or products. These include our own offers or products, or third-party offers or products we think can be interesting for you. If you buy tickets from us, we will enroll you in our newsletter, hence information is required there.

Transaction Notifications: We send you emails or SMS about your account or a ticket purchase. We use your information safely and securely as permitted by law.

Third Parties:

We share your and other clients information with third parties who perform services on our behalf: The information is shared with vendors who help us manage our online registration process, payment processors, or transaction message processors. Some vendors are located in other countries.

Event organizers:

We share your information with event organizers and other parties responsible for fulfilling the purchase obligation. The event organizers and other parties may use the information we give them as described in their privacy policies.

Sanbun's Business Partners: This includes third parties, such as benefactors or sponsors of an event, or avenue organisers where we curate events. Our partners use the information we give them as permitted in their privacy policies.

We share information when there is need to comply with the law or to protect ourselves: We share information to respond to a court order or subpoena. We also share it on the request of government agency or investigatory body requests, or incase of any potential fraud.

We share information with successor: In case we sell a certain part of our business, we may give our customer list as part of that transaction.

We share your information for reasons not described in this policy: We will inform you regarding that and seek your consent first.

Third-party sites: If you click on any link on our website which belongs to any third party, you may visit a page that we do not control. Our privacy policy does not correspond with the privacy practices of those websites. Read the privacy policy of other websites carefully before visiting them. We do not hold any responsibility for these third-party sites.
